

Biography:

Mike Poulson was born in 1944 at Ontario CA. His family farmed in the Corona CA area where they raised walnuts, hay and beans.

As the population grew, small farms were being squeezed out by high property taxes, (some things never change!) and Mike's father looked to relocate. Another farmer the family knew had participated in the lottery for land in the Columbia Basin of WA State which was just starting to be transformed by irrigation water. Mike's dad went through the very detailed process to be eligible to buy a unit of land in the Connell area. In the winter of 1958, the Dean & Phyllis Poulson packed up their four children, and eventually, they arrived in the Connell area where Dean and his two boys started the laborious process of turning their share of "Block 18" into a crop of beans.

Mike said it was a very interesting time because everyone was new to the area and neighbors were drawn together into big "block families" that held annual picnics, and the women formed Homemakers Clubs.

Mike graduated from Connell HS in 1962 and promptly enlisted in the Army National Guard because he just assumed everybody pulled a stint in the military. He completed basic training at Ford Ord in California then went to Fort Lewis to be trained in LVTP-5's - amphibious track vehicles. He eventually ended up being the Chief of the Firing Battery and later 1st Sergeant. Some of Mike's most memorable times and longest friendships (and most entertaining stories) came out of his years in The Guard, and there was no group of guys he'd rather have covering his back.

In 1965, Mike bought some Connell farmland of his own in a nearby unit and started building his own home. Eventually, he added outbuildings and corrals, ran a large herd of cattle, and started planting trees which turned into a lifelong project. Mike left active Guard duty in 1968 and was on inactive reserve for two more years. Mike also farmed full-time even when he was going to high school.

Starting with serving as ASB president in both junior high and high school, Mike admits he was always "mouthy" and wasn't afraid to speak out for what he thought was right which is something he has never stopped doing. While he was actively farming, he was elected VP of the WA State Farm Bureau in the mid-80's.

Mike's first serious steps outside the farm were in the early 1990s when he began doing consulting work on public policy and environmental issues - communicating complex, and often controversial, environmental issues to the public. That meant a lot of trips to Olympia where he ended up working CMR when she was a State Rep.

A few months after CMR was elected to the U.S. House of Representatives, Mike leased out his farmland and joined her staff.

As a farmer, consultant and as a congressional staff person working with constituents, Mike has been up against environmental issues and regulatory burden that continue to grow....and the public attitude that quite often isn't based on facts. One of the best things Mike can offer is a huge network of resources on different sides of the issues and can bring people and groups together to listen and, hopefully, find common ground. It's all about relationships.

Although he isn't afraid to pick up the phone, Mike prefers face to face meetings with people no matter where. He also likes to stand in the back of the room and "just listen" to get a feel for who's there and what they're saying. He thinks nothing of being in Walla Walla early in the morning and being in Republic for an evening meeting with stops in Davenport, Spokane or Colville along the way. His pick-up has over 500,000 miles on it and he's on his way to putting 200,000 miles on his "new car."

When I was elected to the United States Congress, I knew I needed Mike on my team.

After a little convincing, Mike joined and quickly got to work. In the years since, he's logged hundreds of thousands of miles, traveling from one community to another, meeting with farmers, loggers, local government officials and federal resource managers to coordinate, engage, nudge and sometimes push us towards policies that support agriculture and forestry.

Mike has the unique ability to bring together stakeholders with differing viewpoints to find a common solution. He was my eyes and ears in fields and forests for a dozen years and he always conveyed the most vivid picture of the impacts federal proposals would have. It changed laws and helped all of Eastern Washington.

As you consider the new class for the Mid-Columbia Agricultural Hall of Fame, I cannot think of anyone more deserving than Mike Poulson.
